1. Introduction

- 1.1. The project has been supported under the ASPIRE Scheme of Government of India.
- 1.2. The Crescent Innovation & Incubation Council (CIIC) is located at the Seethakathi Nagar, Chatrapatti Post, Madurai, Tamil Nadu 625014. The Centre is located about 15 Km away from Madurai Railway Station and 30 Km away from the Madurai International Airport.
- 1.3. The Incubation Centre has been created to impart skill development training as well as to provide rental manufacturing facilities to existing Entrepreneurs, Farmers, FPO (Farmer Producer Organization), Food Technology Students and MSMEs.
- 1.4. CIIC invites Quotations from Manufacturers/Authorized Dealers/Suppliers for supply/installation and commissioning of various equipment & tools/instruments leading to functioning of the LBI. The details of requirements are provided in the Scope of Work.


2. Minimum eligibility condition to submit bids

Interested Manufacturers/Authorized Dealers/Suppliers must fulfill the following requirements and shall submit necessary documents as indicated below along with their application for pre-qualification for the aforesaid scope of work:

- 2.1. Original Equipment Manufacturer or Authorized Dealer/Supplier certificate with a proven track record.
- 2.2. Must have experience of supply, installation and commissioning of equipment of similar nature.
- 2.3. The Manufacturer/Authorized Dealer/Supplier must have a full time Authorized Representative stationed in Tamil Nadu.
- 2.4. The Manufacturer/Authorized Dealer/Supplier must have valid PAN, GST Registration and other relevant licenses issued by appropriate Authority.
- 2.5. The Manufacturer/Authorized Dealer/Supplier must be financially sound.
- 2.6. The bidder must not be blacklisted/debarred from participation by any Government organization.



5.1. Bidders may bid for all the groups or any of the groups listed. However, the Bidder must be able to supply all the items included in a group.

6. CIIC will evaluate the Technical Bids for short-listing the Bidders and Financial Bids shall be opened only for the Technically Qualified Bidders. **Disqualification** :The bid is liable to be disqualified if:

- 6.1. Not submitted in accordance with this document.
- 6.2. During validity of the bid or its extended period, if any, the Tenderer increases its quoted prices.
- 6.3. During the bid process, if an Tenderer indulges in any such deliberate act that would jeopardize or unnecessarily delay the process of bid evaluation and finalization.
- 6.4. Bid received in incomplete form or not accompanied by bid security amount/ all requisite documents.
- 6.5. Bid received after due date and time.
- 6.6. Tenderer submits conditional bids.
- 6.7. Tenderer indulges in canvassing in any form to win the contract.
- 6.8. Tenderer sub-contracts any part of the project to or employs the goods or services of any of the parties having interest in the project.

7. Financial Bids

- 7.1. Financial bids shall be opened for only technically qualified bidders only.
- 7.2. Financial Bid evaluation shall be based upon all-inclusive total cost of individual packages.


10. General Terms and Conditions

Interested Manufacturers/Authorized Dealers/Suppliers have to fulfill the following requirements and shall submit necessary documents as indicated below along with their application for pre-qualification for the aforesaid scope of work:

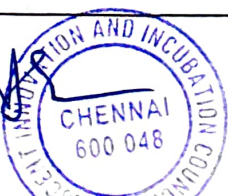
- 10.1. Respondents shall submit Manufacturer's proof of registration/Manufacturer's Certification of appointment of Dealership (If applicable).
- 10.2. Respondents shall submit Experience of supply, installation and commissioning of equipment of similar nature.
- 10.3. The Manufacturer/Authorized Dealer/Supplier must have a full time Authorized Representative stationed at Guwahati.
- 10.4. The Manufacturer/Authorized Dealer/Supplier must submit copies of valid PAN, GST Registration and other relevant licenses issued by appropriate Authority.
- 10.5. The Manufacturer/Authorized Dealer/Supplier must be financially sound and shall submit a CA certified annual turnover with audited P/L copies for last three years.
- 10.6. The delivery of the items and commissioning shall be at Seethakathi Estate, Madurai, Tamil Nadu 625014
- 10.7. All items shall be verified at site for quality and quantity by designated representative(s) of CIIC prior to installation and commissioning.
- 10.8. The Manufacturer/Authorized Dealer/Supplier shall submit a post commissioning Test Report duly certified by the User (As applicable).
- 10.9. Wherever applicable the products shall conform to relevant BIS Standards/possess BIS License.
- 10.10. The supplier shall identify the Country of Origin in case of imported items and shall not supply items imported from any country not permitted by the latest circulars of the Government of India.

11. Force Majeure

- 11.1. For the purposes of this Agreement, "Force Majeure" means an event which is beyond the reasonable control of a Party, and which makes a Party's performance of its obligations hereunder impossible or so impractical as reasonably to be considered impossible in the circumstances, and includes, but is not limited to, war, riots, civil disorder, earthquake, fire, explosion, storm, flood or other adverse weather conditions, strikes, lockouts or other industrial action (except where such strikes, lockouts or other industrial action are within the power of the Party invoking Force Majeure to prevent), confiscation or any other action by government agencies.

- 11.2. Force Majeure shall not include (i) any event which is caused by the negligence or intentional action of a Party or agent's employees thereof, nor (ii) any event which a diligent Party could reasonably have been expected to both (A) take into account at the time of the conclusion of this Agreement and (B) avoid or overcome in the carrying out of its obligations hereunder
- 11.3. Force Majeure shall not include insufficiency of funds or failure to make any payment required hereunder, except for the case of CIIC (buyer) which is receiving funds from the Government grant.
- 11.4. CIIC will decide the eventuality of Force Majeure which will be binding on both the parties.
- 11.5. No breach of Agreement- The failure of a Party to fulfill any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement insofar as such inability arises from an event of Force Majeure, provided that the Party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Assignment. The Agency shall not be liable for forfeiture of its PG or/ and BG, if and to the extent that it's delay in performance or other failure to perform its obligations under the Contract is the result of the Force Majeure.
- 11.6. Measures to be taken:
- i. A Party affected by an event of Force Majeure shall take all reasonable measures to remove such Party's inability to fulfill its obligations hereunder with a minimum of delay.
 - ii. The Agency is expected to report any such event within three days to SPMU in writing.
 - iii. A Party affected by an event of Force Majeure shall notify the other Party of such event as soon as possible, and in any event not later than fourteen (14) days following the occurrence of such event, providing evidence of the nature and cause of such event, and shall similarly give notice of the restoration of normal conditions as soon as possible.
 - iv. d.The Parties shall take all reasonable measures to minimize the consequences of any event of Force Majeure.
- 11.7. Extension of time - Any period, within which a Party shall, pursuant to this Tender, complete any action or task, shall be extended for a period equal to the time during which such Party was unable to perform such action as a result of Force Majeure.
- 11.8. Payment – In the event of Force Majeure is applied, then CIIC will continue to follow the payment schedule by giving concession to selected Tenderer of non-



submission of deliverables for the period of 3 months. Post which, either party is allowed to terminate the contract.

- 11.9. Consultation not later than thirty (30) days after the selected tenderer has, as the result of an event of Force Majeure, become unable to perform a material portion of the Assignment, the Parties shall consult with each other with a view to agreeing on appropriate measures to be taken in the circumstances.

12. Termination Clause: Termination for Insolvency

- 12.1. CIIC may at any time terminate the Contract by giving a written notice of at least 30 days to the selected Tenderer, if the selected Tenderer becomes bankrupt or otherwise insolvent. In such event, termination will be without compensation to the selected Tenderer, provided that such termination will not prejudice or affect any right of action or remedy that has accrued or will accrue thereafter to CIIC.
- 12.2. In such case, CIIC will pay for all the pending invoices as well as the work done till that date by the Tenderer.
- 12.3. Limitation of Liability- In no event shall CIIC be liable for consequential, incidental, indirect, or punitive loss, damage or expenses (including loss of profits).

13. Governing Law

- 13.1. The Contract shall be governed by and interpreted in accordance with the laws of the Tamil Nadu State/ the Country (India) and under the jurisdiction of the Court of Madurai.

14. Contract Award

- 14.1. After issuance of Letter of Invitation (LoI) by CIIC, the selected Tenderer shall sign the contract with SPMU within 15 days.
- 14.2. The selected tenderer is expected to commence the assignment from the date and at the location specified in the Data Sheet/Contract.

15. Period of Completion of assignment and Penalty Clause:

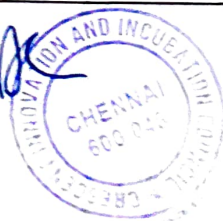
- 15.1. The total period for completion of the work is of 3 months from the date of the signing of the contract. This may be extended by another 1 months with mutual consent and satisfactory performance of the selected tenderer.
- 15.2. CIIC may decide to penalize the selected Tenderer by deducting 1% of the payment linked to the deliverable for every 15 days delay up to an upper limit of 5% of the payment linked to the deliverable.

16. Other terms and conditions

- 16.1. The TED document shall be submitted in English language only.
- 16.2. The Manufacturer/Authorized Dealer/Suppliers shall submit documentary evidence in support of facts/claims submitted/made in response to the TED. Each page of the documents submitted shall be signed and sealed by competent authority of the Manufacturer/Authorized Dealer/Supplier.
- 16.3. The Respondents would be responsible for all its expenses, costs and risks incurred towards preparation of the TED document, attending any pre-bid/bid meeting(s) and visiting the Incubation Center site or any other location in connection therewith. CIIC shall, in no case, be responsible or liable for any such costs whatsoever, regardless of the outcome of the TED process.
- 16.4. Open responses received through e-mail/FAX or any other media shall not be considered and rejected summarily.
- 16.5. Payment shall be made for the supplies within 30 days of receipt of Bills along with certificate of receipt of goods/completion of commissioning work issued by the competent authority of CIIC on the availability of the fund for the said procurement.
- 16.6. For the post delivery services like AMC/Warranty/Guarantee are involved, an amount of 10% of the Contract value shall be retained at the time of payment of the Bills. The said retained amount shall be refunded in full without any interest accrued upon and after deduction, if any due to deficiency in supply after 90 days of completion of the AMC/Warranty/Guarantee period.
- 16.7. The successful Manufacturer/Authorized Dealer/ Suppliers shall enter into an agreement with CIIC for post delivery services of the equipment wherever applicable.
